MEMORANDUM OF UNDERSTANDING

BETWEEN

SANGAMESHWAR COLLEGE, SOLAPUR

Autonomous

AND

SMT. GOPABAI DAMANI BLOOD CENTRE, SOLAPUR



This Agreement is made on the 20th day of September, 2025 between Sangameshwar College, Solapur, Maharashtra, India represented by its Principal Prof. Dr. Ruturaj Buwa. Hereinafter referred to as "SAN College" as the first party and Smt. Gopabai Damani Blood Centre, Solapur Dist. Solapur represented by its Secretary Mr. Jayesh Patel Smt. Gopabai Damani Blood Centre, Solapur Dist. Solapur, hereinafter referred to as SGDB Centre, Solapur as the second party.

PURPOSE

Whereas

- **About Sangameshwar College, Solapur Autonomous:**

Shri. Sangameshwar Education Society's **Sangameshwar College, Solapur Autonomous** affiliated to Punyashlok Ahilyadevi Holkar Solapur University, Solapur was established in the year June 1953 by two Karmayogies: **Late Shri. Nagappa B. Kadadi** and **Late Shri. Madeppa B. Kadadi** with a vision, *'To spread education in general and instruct in any branch of knowledge whenever and wherever feasible'*. Under the capable leadership of Hon'ble Chairman Shri D. A. Kadadi and the youthful, highly accomplished vision of Hon'ble Secretary Ms. J. J. Kadadi, this academic institution has steadily demonstrated its leadership in higher education, always striving towards excellence. The college imparts education in both traditional (B.A., B.Com., B.Sc., M.A., M.Com. M.Sc) and professional courses like BBA, BCA, B.Sc. (ECS) and M.Sc. (CS).

- SAN College, Autonomous , Solapur is desirous to associate with SGDB Centre, Solapur on various areas as discussed in the 'Purview' of this MoU, which will be mutually beneficial to both organizations.

Whereas

- **Smt. Gopabai Damani Blood Centre, Solapur Dist. Solapur**

- SGDB Centre, Solapur was established in 1958 by Shri. B.R Damani and Shri. P.R. Damani. It was established with cooperation of the Damani Group and the Indian Red Cross Society.

- The initial fund for the infrastructure were provided by Mrs. Gopabai Damani, with additional contributions from the Damani group , state branch and Solapur municipal corporation.

- SGDB Centre, Solapur is desirous to associate with SAN College, Autonomous, Solapur on various areas as discussed in the 'Purview' of this MoU, which will be mutually beneficial to both organizations.

That,

- Relying on the principle of good faith, by virtue of which they will carry out all the possible actions for their due fulfillment, *and*
- Relying also on their common bonds and concerns, they state their interest in strengthening their relationships through social activity by donating blood and for this end they are entering into this MoU.

NOW THEREFORE THIS MEMORANDUM OF UNDERSTANDING WITNESS AS FOLLOWS:

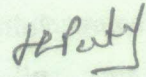
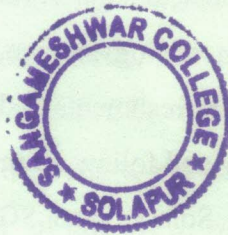
1. The scope of this Memorandum of understanding includes exchange in following aspects:-
 - a. To promote awareness on the importance of voluntary blood donation.
 - b. To organize regular blood donation camps at the college with active participation from NCC cadets.
 - c. To encourage social responsibilities and Social service among NCC cadets regarding blood donation.
 - d. Organise a Guest lectures for students and faculty.
 - e. Jointly organise the conferences, seminars and workshops
 - f. Provide technical and medical support for organizing blood donation camps.
 - g. Ensure proper collection, testing, storage, and utilization of the donated blood.
 - h. Provide certificates and refreshments to donors.
 - i. Maintain confidentiality and follow all medical and legal protocols.
2. Both SAN College, Autonomous, Solapur and SGDB Centre, Solapur will make concrete proposals for implementation of these exchanges and work towards their realization in close contact with each other.
3. This memorandum can be altered by mutual consent of both the parties and by the request of SAN College, Autonomous, Solapur and SGDB Centre, Solapur. Any alternations shall become effective at the time that both the parties indicate their consent in writing.
4. Financial terms for specific programs, events, seminar and workshop shall be decided on mutual understanding between SAN College, Autonomous, Solapur and SGDB Centre, Solapur
5. **AUTONOMY:** This agreement is a statement of intentions and does not involve, any instance whatsoever, any financial obligations between the subscribing institutions.
6. **TERM:** This MoU shall be effective for a period of 5 years from the date of execution of this agreement and shall be automatically renewed thereafter for another 5 years unless a written notice of terminate or amend this agreement is given to the other party 6 months in advance.
7. **CONFLICT RESOLUTION:** Any dispute resulting from the interpretation or application of this agreement shall be settled through direct negotiation and common agreement by the persons delegated to such end by each institution. Either party may propose to modification of the Agreement at anytime in writing.
8. **CONFIDENTIALITY:** Each of the parties accepts and declares that information shared from the other party is of a confidential nature. Every piece of information provided by one party to the other before signing this Agreement and/or during its performance must be kept

9. **AMENDMENTS:** The parties may amend or amplify this Agreement through agreements in writing to that effect. Said amendments or additions will be binding on the signatories as of the date of their signature. The parties may not assign, in whole or in part, the performance of the present MoU to any third party, except through prior and express authorization in writing by both of them. And since both parties are in agreement regarding the content of the present document, and as a token of conformity, we sign it in two counterparts, both of which will be considered originals.

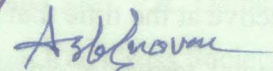
